Enjoy extra cash when you request to skip your November 2021 or December 2021 loan payment on qualifying Maple Federal Credit Union loans.*

There is a processing fee of \$35 per loan skipped. There will be an additional \$20 collected if you decide to open a Christmas Club account. All parties who signed the original loan document are required to sign below. All requests are subject to approval.

*Loans not eligible for Skip-A-Payment include Visa®, overdraft protection lines of credit and \$1000 or \$1500 special loans. All accounts with Maple FCU must be in good standing and your loans may not have been in excess of 60 days past due in the last 6 months to qualify. Members who have received requested loan extensions in the last 6 months or loans less than 6 months old do not qualify. Additional qualifications may apply for a vehicle loan Skip-A-Payment request.
